**Supplementary Childcare Service (SEB)  
and Supervised Lunch for Kindergarten  
and Primary School Children**

## Services, locations and opening hours

The offer of supplementary school care, SEB for short, is aimed at children of kindergarten and primary school age and is offered at the five SEB locations Aumatten, Fiechten, Reinacherhof, Surbaum (from August 2024) and Weiermatten. The SEB is run by (socio-)pedagogically trained specialists in collaboration with other caregivers.

The offer includes the following modules:

Module 0		07.00-08.00	Early care incl. breakfast (exclusively pilot operation SEB Surbaum)
Module 1		12.00-13.45	Lunchtime supervision incl. lunch
Module 2	2a 2b 2c 2d	13.45-16.05 14.55-16.05 15.15-16.05 15.45-16.05	Afternoon care
Module 3		16.05-18.00	After-school care incl. snacks

Morning module 0 will be offered in a pilot operation at the new SEB site in Surbaum from August 2024. Breakfast is included.

Lunch in module 1 will be delivered to all locations. Homework supervision is included in modules 2 and 3. In Module 3, each child receives an afternoon snack.

During a maximum of 11 weeks in the school vacations, full-day vacation care is provided (see separate flyer), which can be booked individually.



## Registration and organization

Attendance at a SEB is only possible with a binding registration for an entire school term. Each of the modules can be attended individually and for between one and five days a week. The registration of least five children per location and module (or per day of vacation camp) is required for these childcare services to be provided.

In the case of the vacation camps, a child has to be registered for the entire day. The children have to be able to make their own way to the SEB. Any transport costs are to be covered by the parents/legal guardians.



## Costs

This range of childcare services is subsidized by the municipality of Reinach for children who are resident in Reinach. The contribution of the parents/legal guardians to the costs of the childcare is determined on the basis of their income level. The relevant income is determined on the basis of the data submitted to our fiscal administration. Calculations are made according to the Regulations Governing Supplementary Childcare.
